The parties in this matter agree to the terms and conditions of the attached Stipulation, subject to the approval of the Board. The Board has reviewed this Stipulation and considers it acceptable.

In the interest of resolving this matter, Respondent neither admits nor denies the allegations against her and consents to the entry of the following Findings of Fact, Conclusions of Law and Order.

Accordingly, the Board in this matter adopts the attached Stipulation and makes the following:

FINDINGS OF FACT

1. Frances Ann Korytkowski (D.O.B. 01/16/1960) is duly licensed as a practical nurse in the state of Wisconsin (license #23262). This license was first granted on 12/09/1980.
2. Respondent's most recent address on file with the Wisconsin Board of Nursing is 1221 Grandview Boulevard, Waukesha, WI 53188.
3. At all times relevant to this action, Respondent worked as a licensed practical nurse at River Hills West Health Care Center ["River Hills"], 321 Riverside Drive, Pewaukee, Wisconsin. River Hills is a long-term care facility.
4. On December 1, 1999 at approximately 6:00 a.m., a licensed practical nurse checked on the condition of PC, an elderly female resident of River Hills. The LPN charted that she was unable to detect a pedal pulse in PC's left foot. She also noted a small bruise on the top of PC's left foot, that her left foot was ruddy colored and that it was slightly cool.
5. The nurses' notes and other charting for PC reveal no follow-up regarding the lack of a pedal pulse for this resident during the interim between the noted lack of pedal pulse on December 1, 1999 and the time Respondent took care of PC on December 4, 1999.

6. Respondent's charting for PC on December 4, 1999 reads in pertinent part as follows:

0200	T 100.1/0 P-104 R 20 Resident awake, talkative admits to discomfort to (L) foot only with use. Steri strips intact, scant amt of drainage, continues on ABT therapy Duricef for foot infection...
0330	Retake temperature 100/0

Respondent's charting on December 4, 1999 for PC fails to include any documentation of pedal pulse, nor does the charting contain any reference to examination for capillary refill, temperature of foot or comparison of PC's left foot with her right.

7. Respondent's next charting for PC is on December 5, 1999 and reads in pertinent part as follows:

2410	Resident found dropped over side of bed/ unclothed. "I tried to toilet myself but fell." Incident unwitnessed.... Resident only admits to discomfort to Lt foot, which is red, swollen, dressing applied, steri strips intact. Tylenol given for discomfort

Respondent's charting on December 5, 1999 for PC fails to include any documentation of pedal pulse, nor does the charting contain any reference to examination for capillary refill, temperature of foot or comparison of PC's left foot with her right.

8. Respondent's next charting for PC is on December 6, 1999 and reads in pertinent part as follows:

2200	BP 130/70 P-112 R 16 ROM to [upper] + [lower] extremities WNL, hand grasp =/ strong, uncooperative [with] crane [check]. Tylenol given for foot discomfort, steri strips intact.
2315	Resident encouraged to be assisted to bathroom but refused and was incontinent. Continues on ABT therapy, Duricef for infected foot.
0200	Resident continues on ABT therapy for foot, refused to let this writer look at it under sock, tender to touch....
0500	BP 160/80 P 88 R 20 ROM to [upper] + [lower] extremities WNL, hand grasp =/ strong. Does not tolerate weight well. Small amt. of serous drainage noted to Lt foot, bandage intact, redness [decreased], edema [decreased]

Respondent's charting on December 6, 1999 for PC does not include any documentation of pedal pulse, nor does the charting contain any reference to examination for capillary refill, temperature of foot or comparison of PC's left foot with her right.

9. Respondent's next charting for PC is on December 8, 1999 and reads in pertinent part as follows:

2330	Resident transferred to shower chair with assist of [2], did not bear any wt. Refused to actively use bilateral feet. T100.2/0 P. 100 R. 20 Resident admits to discomfort Lt foot, redness noted, scant amt of drainage noted to drsg which is intact to top of foot.... Transferred back to bed with two man carry. At this time resident c/o discomfort to legs, multiple bruises noted to Rt leg will continue to monitor
300/AM	Toileted at this time.... Assist back to bed, continues on ABT therapy Duricef continues....

Respondent's charting on December 8, 1999 for PC fails to include any documentation of pedal pulse, nor does the charting contain any reference to examination for capillary refill, temperature of foot or comparison of PC's left foot with her right.

10. Respondent's next charting for PC is on December 9, 1999 and reads in pertinent part as follows:

0415/am	Resident.... Does not bear wt when being transferred to shower chair. Redness continues to Lt leg, [increase] in area to upper shin region, steri strips intact, resident admits to discomfort, [no] edema at this time. Purple discoloration continues....

Respondent's charting on December 9, 1999 for PC fails to include any documentation of pedal pulse, nor does the charting contain any reference to examination for capillary refill, temperature of foot or comparison of PC's left foot with her right.

11. On December 9, 1999, PC was taken to a vascular surgeon at the request of her family. The vascular surgeon who examined PC on December 9, 1999 found no pulse in PC's left foot and observed that PC's left foot was mottled, "ice cold" and "essentially dead."

12. In resolution of this matter, Respondent consents to the issuance of the following Conclusions of Law and Order.

CONCLUSIONS OF LAW

1. The Wisconsin Board of Nursing has jurisdiction over this matter, pursuant to sec. 441.07, Stats.
2. The Wisconsin Board of Nursing is authorized to enter into the attached stipulation, pursuant to sec. 227.44(5), Stats.
3. By the conduct described above, Frances Ann Korytkowski is subject to disciplinary action against her Wisconsin nursing license, pursuant to sec. 441.07(1), Wis. Stats., and Wis. Admin. Code §§N7.03 (1) and N7.04 (4) and (15).

ORDER

NOW, THEREFORE, IT IS HEREBY ORDERED that Frances Ann Korytkowski LPN (license #23262) is REPRIMANDED.

IT IS FURTHER ORDERED that the Wisconsin nursing license of Frances Ann Korytkowski (license #23262) is LIMITED as follows:

1. Respondent shall comply with all statutes and code provisions relating to the practice of nursing.

Practice restrictions

2. Until otherwise ordered by the Board
 - a. Respondent shall practice only in settings where she works under supervision by another nurse or other licensed health care professional.
 - b. Respondent shall refrain from nursing employment as a pool nurse; and
 - c. Respondent shall refrain from nursing employment as a visiting nurse or other home care practitioner

Education Requirement

3. Within twelve (12) months from the effective date of this Order, Respondent shall submit documentation of successful completion of at least six (6) hours of continuing nursing education approved by the Board in the subject areas of patient charting and legal aspects of nursing and six (6) hours in caring for patients with circulatory problems, or in other areas approved by the Board. To be acceptable, a course shall be pre-approved by a member or designated agent of the Board of Nursing. Acceptable documentation shall include certification from the sponsoring organization as well as a statement signed by Respondent verifying that she attended the course in its entirety.

Required reporting

4. For a period of at least one [1] year from the date of this Order, Respondent shall arrange for quarterly reports from her nursing employer(s) reporting the terms and conditions of her employment and evaluating her work performance. These reports shall be submitted to the Department Monitor in the Department of Regulation and Licensing Division of Enforcement.

5. Respondent shall notify the Department Monitor of any change of employment during the time in which the Order is in effect. Notification shall occur within fifteen (15) days of a change of employment and shall include an explanation of the reasons for the change.

Department Monitor

6. The Department Monitor is the individual designated by the Board as its agent to coordinate compliance with the terms of this Order, including receiving reports and coordinating all requests for approval of education or other petitions. Petition for Termination of restrictions

7. Upon completion of: one [1] year of complete, successful and continuous compliance with the terms of this Order that includes one [1] year of nursing employment under the terms of this Order; Respondent may petition the Board to revise or eliminate any of the above conditions. Denial in whole or in part of a petition under this paragraph shall not constitute denial of a license and shall not give rise to a contested case within the meaning of Wis. Stats. §§227.01(3) and 227.42.

Agency Caregiver Finding

8. If Respondent fails to fully and completely comply with all terms and conditions set forth above or if the Department receives a subsequent credible allegation against Respondent of abuse, neglect or misappropriation, the Department Monitor shall without further notice or hearing notify the Wisconsin Department of Health and Family Services that the findings set forth in this Order shall thereafter constitute an agency finding of neglect for the purposes of secs. 48.685 and 50.065, Wis. Stats. Respondent shall then REFRAIN from any nursing employment in any facility licensed by the Wisconsin Department of Health and Family Services until such time as Respondent successfully completes a rehabilitation review administered by DHFS.

SUMMARY SUSPENSION

9. Violation of any of the terms of this Order may in addition be construed as conduct imperiling public health, safety and welfare and may result in a summary suspension of Respondent's license pursuant to the procedures set forth in Wis. Admin. Code RL Ch. 6. The Board in its discretion may in the alternative impose additional conditions and limitations or other additional discipline for a violation of any of the terms of this Order.

Effective date of Order

10. This Order shall become effective upon the date of its signing.
