The parties in this matter agree to the terms and conditions of the attached Stipulation as the final decision of this matter, subject to the approval of the Board. The Board has reviewed this Stipulation and considers it acceptable.

Accordingly, the Board in this matter adopts the attached Stipulation and makes the following:

FINDINGS OF FACT

- 1. Modern Nails of Milwaukee, 1223 West Historic Mitchell Street, Milwaukee, WI 53204, is duly licensed as a manicuring establishment in the state of Wisconsin (license #1906). This license was first granted on July 9, 2001.
- 2. Nhan T. Tran, 7931 South 47th Street, Franklin, WI 53132, is listed with the Department of Regulation and Licensing as the owner of Modern Nails of Milwaukee. As owner, Nhan T. Tran was and is at all times relevant to this action responsible for compliance with ch. 454, Stats. and Wisconsin Administrative Code chs. BC 2, 3 and 4.
- 3. On or about November 14, 2001, an inspection of Modern Nails of Milwaukee revealed one unclean workstation (not in use at the time of inspection) and floors littered with nail clippings and acrylic nails.
- ${\bf 4.\ In\ resolution\ of\ this\ matter,\ Respondent\ consents\ to\ the\ entry\ of\ the\ following\ Conclusions\ of\ Law\ and\ Order.}$

CONCLUSIONS OF LAW

By the conduct referred to in ¶ 3, above, Nhan T. Tran, d/b/a Modern Nails of Milwaukee, violated sec. 454.15(2)(i), Stats. and Wis. Admin. Code §BC 4.01(1).

ORDER

NOW, THEREFORE, IT IS HEREBY ORDERED that

- 1. Respondent shall pay to the Department of Regulation and Licensing a forfeiture of ONE HUNDRED dollars (\$100.00). Payment shall be submitted within thirty [30] days from the date of this order. Payment shall be made by *certified check or money order*, payable to the Wisconsin Department of Regulation and Licensing and sent to: Department Monitor, Division of Enforcement, PO Box 8935, Madison, WI 53708-8935
- 2. In the event Nhan T. Tran fails to timely pay the forfeiture set forth in ¶ 1 above, the establishment license of Modern Nails of Milwaukee (#1906) SHALL BE SUSPENDED, without further notice or hearing, until payment is received.
- 3. This Order shall become effective upon the date of its signing.
