The parties in this matter agree to the terms and conditions of the attached Stipulation as the final decision of this matter, subject to the approval of the Board. The Board has reviewed this Stipulation and considers it acceptable.

Accordingly, the Board in this matter adopts the attached Stipulation and makes the following:

**FINDINGS OF FACT**

1. Susan A. Straubhaar, date of birth, March 5, 1966; 11040 Straubhaar Road, Blue Mounds, WI 53517) is duly licensed as a Barbering or Cosmetology Manager (license #26336). This license was first granted on January 3, 1996.
2. Ms. Straubhaar is the owner of Styles with Smiles, a licensed Barbering or Cosmetology Establishment, presently located at 330 W. Main Street, Mount Horeb, WI 53572. The establishment license (license # 29461) was first granted on November 10, 2000.
3. Ms. Straubhaar's establishment and manager's licenses expired July 1, 2001. On exact dates unknown, but at least between July 1, 2001 and November 8, 2001, Ms. Straubhaar performed barbering and cosmetology services at her establishment, Styles with Smiles, 300 W. Main Street, Mount Horeb, WI 53572 after her licenses had expired.
4. Ms. Straubhaar did not renew her Barbering or Cosmetology establishment and manager's licenses until November 8, 2001 due to personal and financial difficulties.
5. In resolution of this matter, Susan A. Straubhaar consents to the entry of the following Conclusions of Law and Order.

## CONCLUSIONS OF LAW

By the conduct referred to above, Susan A. Straubhaar is subject to discipline pursuant to sec. 454.04(1) Stats.

## ORDER

NOW, THEREFORE, **IT IS HEREBY ORDERED** that

1. Within the time frame specified below in Paragraph 3, Susan A. Straubhaar shall pay to the Department of Regulation and Licensing a forfeiture of ELEVEN HUNDRED dollars [\$1,100.00].
2. Payment shall be made by ***certified check or money order***, payable to the Wisconsin Department of Regulation and Licensing and sent to: Department Monitor, Division of Enforcement, PO Box 8935, Madison, WI 53708-8935.
3. Respondent shall have twenty-four (24) months to pay the forfeiture in full. Partial payments shall be submitted by at least the following installment schedule:

**4. In the event that Susan A. Straubhaar fails to timely pay the forfeiture set forth above, her manager's license (26336) and establishment license (#29461) SHALL BE SUSPENDED, without further notice or hearing, until Respondent has complied with the terms of this Order.**

5. This Order shall become effective upon the date of its signing.
