Accordingly, the Board in this matter adopts the	e attached Stipulation and makes the following:
FINDINGS OF FACT	

- 1. Respondent Evelyn M. Fuller, R.Ph. (d.o.b. 01/26/70), is and was at all times relevant to the facts set forth herein a registered pharmacist licensed in the State of Wisconsin pursuant to license # 12094, originally granted on 06/17/94. Respondent is the managing pharmacist of Walgreens store # 1685, Milwaukee, Wisconsin.
- 2. On 8/24/01 a prescription order was issued to CJ for Mucomyst® (acetylcysteine), 20 % solution in a quantity of 800 mg. The filling pharmacist calculated the prescription to be 8000 mg. Respondent did not recalculate the prescription or check the label for accuracy before dispensing the prescription to CJ. The label in pertinent part read:

"mix contents of 10 vials in juice twice daily for 7 days starting 3 days BN procedure."

CONCLUSIONS OF LAW

A. The Wisconsin Pharmacy Examining Board has jurisdiction to act in this matter pursuant to §450.10, Wis. Stats. and is authorized to enter into the attached Stipulation pursuant to §227.44(5), Wis. Stats.

B. The conduct described in paragraph 2, above, violated § 450.10(1)(a)(6) Stats., and Phar. 7.01(1)(d) and (e) and 10.03(2) Wis. Adm. Code. Such conduct constitutes unprofessional conduct within the meaning of the code and statutes.

ORDER

NOW, THEREFORE, IT IS HEREBY ORDERED, that the attached Stipulation is accepted.

IT IS FURTHER ORDERED, that, Evelyn M. Fuller, R.Ph., is REPRIMANDED for her unprofessional conduct in this matter.

IT IS FURTHER ORDERED, that Respondent shall certify to the Board the successful completion of an approved course of continuing education of not less than 10 hours in error prevention and quality assurance within one year of the date of this order. This course requirement shall be in addition to the continuing education required under sec. 450.085 Stats. Respondent will be responsible for locating a course of training acceptable to the Pharmacy Examining Board and for obtaining the required course pre-approval from the Board or its designee. Respondent shall be responsible for all costs of the completion of the required training. Within 60 days of completion of the required training Respondent shall certify completion of the educational requirement to the Wisconsin Pharmacy Examining Board by the method provided in sec. Phar. 16.04 Wis. Adm. Code. All required documentation is to be filed with the Department Monitor, Department of Regulation and Licensing, Division of Enforcement, P.O. Box 8935, Madison, WI 53708-8935, tel. (608) 267 3817.

IT IS FURTHER ORDERED, that respondent shall pay COSTS in this matter in the amount of \$ 300.00, within 30 days of this order to the Department of Regulation and Licensing.

IT IS FURTHER ORDERED, that an investigator of the department shall observe the practice of pharmacy at respondent's practice location, without advance notice to respondent, at a time convenient to the department, but no less than six nor more than twelve months from the date of this Order. Respondent shall cooperate by furnishing respondent's work schedule upon request.

IT IS FURTHER ORDERED, that pursuant to §227.51(3), Wis. Stats., and ch. RL 6, Wis. Adm. Code, if the Board determines that there is probable cause to believe that respondent has violated any term of this Final Decision and Order, the Board may order that the license of respondent be summarily suspended pending investigation of the alleged violation.
