On May 15, 2002, the Veterinary Examining Board issued its Final Decision and Order in the above-captioned matter. By the terms of the board's Order, Dr. Khan's license was limited in part to require that within six months from the date of the order, he participate in and satisfactorily complete a declawing training program. The declawing training program required Dr. Khan to observe ten (10) declawing procedures performed by a veterinarian approved by the Veterinary Examining Board, and to satisfactorily perform five (5) declawing procedures under the supervision of a veterinarian approved by the Board.

On November 13, 2002, the Veterinary Examining Board considered evidence that Dr. Khan has fully complied with the limitations on his license. Accordingly, it is ordered as follows:

ORDER

NOW, THEREFORE, IT IS ORDERED that all limitations on the license of Kamran M. Khan are terminated, and Dr. Khan is reinstated to full licensure.
