A pplicant LS0205231CHI

On or about November 2, 2001, Shawn M. Giese filed an application for a license to practice chiropractic in Wisconsin. The information received in the application process reflects that the applicant's conviction record includes convictions substantially related to the practice of chiropractic. Applicant has entered into a Stipulation by which Applicant agrees to accept a license to practice chiropractic subject to specified conditions. Based upon the stipulation and information of record herein, it is ORDERED as follows:

ORDER

NOW, THEREFORE, IT IS ORDERED that Shawn M. Giese is granted a license of license to practice chiropractic, subject to the following terms and conditions:

- 1. Within ninety [90] days from the date of this order and prior to engaging in any patient contact, Applicant shall submit a current report of chemical a dependency assessment of Applicant performed by a Wisconsin certified A ODA counselor or other health care provider acceptable to the Board.
 - a. Applicant shall obtain Board approval of the assessor prior to the assessment

being performed.

b. The assessor shall submit a written report of his or her findings directly to the Board, including: a diagnosis of Applicant's condition (if any); recommendations for treatment; an evaluation of Applicant's level of cooperation in the assessment process; ability to work and work restriction recommendations; and Applicant's prognosis. The assessment shall reflect that the assessor has received and reviewed copies of this order as well as Division investigative materials regarding Applicant's behavior. To be considered current, the assessment shall be conducted within not more than thirty (30) days from the date of the petition.

Compliance

- 2. Applicant shall timely and fully comply with any recommended treatment, education, work restrictions or other recommendations made by his assessor. Applicant shall not commence patient contact without prior approval of the Board. The Board reserves the right to establish terms and conditions that will enable it to monitor Applicant's compliance with any treatment recommendations or work restrictions.
- 3. Applicant shall be responsible for all expenses incurred by him in complying with the terms of this Order.

Required reporting

4. Applicant shall notify the Department Monitor of any and all arrests and/or criminal charges filed against him during the time in which this Order is in effect. Notification shall occur within five (5) days of the arrest or issuance of charges and shall include sufficient information to the Monitor to obtain adequate background information on the incident reported.

Department Monitor

5. The Department Monitor shall act as the agent of the Chiropractic Examining Board to coordinate compliance with the terms of this Order, including coordinating all requests for approval of education or other petitions. The Department Monitor may be reached as follows:

Termination of restrictions

6. Upon complete, successful and continuous compliance with the terms of this O rder for a period of one [1] year, the Applicant may petition for full and unrestricted license status. Denial in whole or in part of a petition under this paragraph shall not constitute denial of a license and shall not give rise to a contested case within the meaning of Wis. Stats. §§227.01(3) and 227.42.
