**Division of Enforcement Case No. 01 BAC 104**

On June 5, 2002, the Barbering and Cosmetology Examining Board adopted a Stipulation and Final Decision and Order in the above matter. The Order provided that Ms. Hansen was to pay a forfeiture of one thousand dollars (\$1,000.00). Due to an inadvertent mistake in the Order, Ms. Hansen was given both sixty (60) days and an installment payment schedule to pay the \$1,000.00 Forfeiture. This Corrected Final Decision and Order is to clarify the intent of the previous Final Decision and Order.

Ms. Hansen is not required to pay the \$1,000.00 forfeiture within sixty (60) days. Ms. Hansen is to pay the one thousand dollars (\$1,000.00) forfeiture on the following installment schedule:
