The parties in this matter agree to the terms and conditions of the attached Stipulation as the final decision of this matter, subject to the approval of the Board. The Board has reviewed this Stipulation and considers it acceptable.

Accordingly, the Board in this matter adopts the attached Stipulation and makes the following:

**FINDINGS OF FACT**

1. Peggy Hansen, 208 McKinley Boulevard, Eagle River, WI 54521, is listed with the Department of

Regulation and Licensing as the owner of the licensed barbering and cosmetology establishment in the State of Wisconsin, known under the trade name, Shear Precision.

2. Shear Precision is licensed with the Department of Regulation and Licensing as a barbering and cosmetology establishment in Eagle River, Wisconsin (new license #30297). This license was first granted on October 3, 1988.

3. Peggy Hansen was at all times relevant to this action the licensed manager for Shear Precision, having license (#11147), first granted on April 30, 1971.

4. As owner-manager of a licensed barbering and cosmetology establishment, Ms. Hansen was responsible for compliance with ch. 454, Stats., and Wisconsin Administrative Code chs. BC 2, 3 and 4.

5. On July 1, 1995, the establishment license of Shear Precision expired and was not renewed until February 27, 2002. During this period of time the establishment operated as a barbering and cosmetology establishment.

6. Shear Precision needed to apply for a new establishment license since more than five (5) years had elapsed since the establishment license was renewed.

7. In resolution of this matter, Peggy Hansen consents to the entry of the following Conclusions of Law and Order.

### CONCLUSIONS OF LAW

By the conduct referred to in ¶ 3 above, Peggy Hansen violated sec. 454.08(1)(b), Stats. and Wis. Admin. Code §§ BC 2.04(1) and BC 3.01(1).

### ORDER

1. NOW, THEREFORE, **IT IS HEREBY ORDERED** that Peggy Hansen shall pay to the Department of Regulation and Licensing a forfeiture of ONE THOUSAND dollars (\$1000.00). Payment shall be submitted within 60 days from the date of this order. Payment shall be made by **certified check or money order**, payable to the Wisconsin Department of Regulation and Licensing and sent to:

**3. IT IS FURTHER ORDERED** that in the event Peggy Hansen fails to timely submit payment of the forfeiture as set forth above, the establishment license of Shear Precision (#30297) **SHALL BE SUSPENDED**, without further notice or hearing, until Respondent have complied with the terms of this Order.

This Order shall become effective upon the date of its signing.
