The parties in this matter agree to the terms and conditions of the attached Stipulation as the final decision of this matter, subject to the approval of the Board. The Board has reviewed this Stipulation and considers it acceptable.

Accordingly, the Board in this matter adopts the attached Stipulation and makes the following:

# FINDINGS OF FACT

- 1. Tyrone A. Harrison, (DOB 03/19/1952; 4521 North 38<sup>th</sup> Street, Milwaukee, WI 53209) was at all times relevant to this action working as manager of record of barbering and cosmetology establishment Hair Connection Beauty & Barber. As manager, Mr. Harrison was responsible for compliance with ch. 454, Stats., and Wisconsin Administrative Code chs. BC 3 and 4.
- 2. On exact dates unknown, Mr. Harrison stopped working as manager of record at Hair Connection Beauty & Barber. However, Mr. Harrison failed to notify the Department of Regulation and Licensing that he was no longer manager of Hair Connection Beauty & Barber. Mr. Harrison alleges that he discontinued working as manager of the establishment sometime during the summer of 2000.
- 3. An inspection of Hair Connection Beauty & Barber by a Department of Regulation and Licensing Investigator was conducted on or about November 8, 2000. During that inspection the owners indicated that Mr. Harrison was still the manager of the establishment.
- 4. In resolution of this matter, Tyrone A. Harrison consents to the entry of the following Conclusions of Law and Order.

#### **CONCLUSIONS OF LAW**

By the conduct described above, Tyrone A. Harrison is subject to disciplinary action against his license, pursuant to sec 454.15(2)(c), Stats.

## ORDER

#### NOW, THEREFORE, IT IS HEREBY ORDERED that

- 1. Mr. Harrison shall pay to the Department of Regulation and Licensing a forfeiture of THREE HUNDRED dollars (\$300.00). Payment shall be submitted within ninety [90] days from the date of this order. Payment shall be made by *certified check or money order*, payable to the Wisconsin Department of Regulation and Licensing and sent to: Department Monitor, Division of Enforcement, PO Box 8935, Madison, WI 53708-8935
- 2. In the event Tyrone A. Harrison fails to timely pay the forfeiture set forth in ¶ 1 above, his manager's license (#26188) SHALL BE SUSPENDED, without further notice or hearing, until Respondent has complied with the terms of this Order.
- 3. This O rder shall become effective upon the date of its signing.
