On October 16, 2002, the Social Worker Section of the Examining Board of Social Workers, Marriage and Family Therapists and Professional Counselors reviewed the report of Lois Cochrane Schlutter in partial completion of the Final Decision and Order in this case dated June 13, 2002. The section determined that Ms. Klein has complied with the Order, and that reinstatement of her certificate is appropriate, but that additional limitations on her certificate are also appropriate. Therefore,

IT IS ORDERED that the suspension of the independent clinical social worker certificate granted to Cynthia J. Klein is hereby terminated and the certificate is reinstated.

IT IS FURTHER ORDERED that the certificate as an independent clinical social worker granted to Cynthia J. Klein is hereby limited as follows:

- 1. Ms. Klein shall continue therapy as recommended by Dr. Schlutter, i.e. that for a period of one year, Ms. Klein obtain intermittent ongoing therapy to deal with the mild-severity personality issues uncovered in the testing, as well as any episodes of omnipotent thinking, manipulation, overly helpful urges, or episodes of anger which may recur rarely, and
- 2. Ms. Klein shall obtain supervision for her social work practice that conforms with chapter SFC 4 of the Administrative Code (version effective November 1, 2002 attached). The supervision must be provided by someone other than a business partner and from an individual approved by the Section in advance.
- 3. Ms. Klein shall arrange with her therapist and with her supervisor for the submission of written quarterly reports from each, to be submitted to
