The Wisconsin Dentistry Examining Board received a Stipulation submitted by the parties to the above-captioned matter. The Stipulation, a copy of which is attached hereto, was executed by Rhonda Kay Clancey, personally on her own behalf, and by Michael J. Berndt, attorney for the Department of Regulation and Licensing, Division of Enforcement. Based upon the Stipulation of the parties, the Wisconsin Dentistry Examining Board makes the following Findings of Fact, Conclusions of Law and Order.

FINDINGS OF FACT

1. Rhonda Kay Clancey was born December 8, 1953. Ms. Clancey’s latest address on file with the Department of Regulation and Licensing is 1212 Whippoorwill Circle, Neenah, WI 54956.
2. Ms. Clancey's license to practice dental hygiene in the state of Wisconsin was first granted on July 25, 1977.

3. On September 1, 1979, Ms. Clancey's Wisconsin dental hygiene license expired, since that time Ms. Clancey has continued to practice in the state of Wisconsin as a dental hygienist without current licensure.
4. Ms. Clancey now understands that she needs a current license to practice as a dental hygienist in the state of Wisconsin. In resolution of this matter, Ms. Clancey consents to the entry of the following Conclusions of Law and Order.

CONCLUSIONS OF LAW

1. The Dentistry Examining Board has jurisdiction in this matter pursuant to § 447.03 (2), Stats., and § 447.07(3), Stats.
2. The Dentistry Examining Board has authority to enter into this stipulated resolution without an evidentiary hearing pursuant to § 227.44(5), Stats. and § 440.22, Stats.
3. The conduct described in paragraph 3 in the Findings of Fact constitutes unprofessional conduct as defined by Wis. Adm. Code § DE 5.02 (16).

ORDER

NOW, THEREFORE, IT IS ORDERED that the stipulation of the parties is approved.

IT IS FURTHER ORDERED that:

1. Rhonda Kay Clancey is hereby REPRIMANDED.
2. Ms. Clancey shall, within six (6) months from the date of this Order, pay a forfeiture of one thousand five hundred dollars (1,500.00) and partial costs of this proceeding in the amount of two hundred fifty (\$250.00) dollars. 3. Ms. Clancey will also be required to appear before the Dentistry Examining Board at their next scheduled meeting on July 10, 2002 to answer any questions the Board may have.
4. The pending investigation, 02 DEN 039, shall be, and hereby is, closed without further proceedings.

The rights of a party aggrieved by this Final Decision and Order to petition the Wisconsin Dentistry Examining Board for rehearing and to petition for judicial review are set forth in the attached "Notice of Appeal Information."

This Order shall become effective on the date of its signing.
