The parties in this matter agree to the terms and conditions of the attached Stipulation as the final decision of this matter, subject to the approval of the Board. The Board has reviewed this Stipulation and considers it acceptable.

Accordingly, the Board in this matter adopts the attached Stipulation and makes the following:

FINDINGS OF FACT

1. Jose Sanchez is listed with the Department of Regulation and Licensing as the owner of Supreme Clientele Hair Studios, a duly licensed barbering and cosmetology establishment in the State of Wisconsin.

2. Supreme Clientele Hair Studios is located at 1114 W. Historic Mitchell Street, Milwaukee, WI 53204. The establishment first received its barbering and cosmetology establishment license in the State of Wisconsin (license #80-30131) on November 16, 2001.

3. As the owner of a licensed establishment, Jose Sanchez, was at all times relevant to this action responsible for compliance with ch. 454, Stats. and Wisconsin Administrative Code, chs. BC 2, 3 and 4.

4. On exact dates unknown, but beginning at least on October 19, 2001 and continuing through November 16, 2001, Supreme Clientele Hair Studios was providing barbering and cosmetology services to the public without a valid establishment license.

5. On exact dates unknown, but beginning at least on October 19, 2001 and continuing through November 16, 2001, Supreme Clientele Hair Studios was operating without a licensed manager for the establishment.

6. On November 14, 2001, the Department conducted an unannounced inspection of Supreme Clientele Hair Studios and found an unlicensed person, David Vazquez, at the establishment. Vazquez admitted to the Department inspector that he had provided barbering and cosmetology services to the public without a license or apprenticeship permit. Vazquez had previously held an apprentice contract for another establishment, which had been canceled on November 1, 2000. A copy of the Apprenticeship Cancellation Notice is attached and marked as State's **Exhibit 1**.

7. The inspection revealed that the establishment was not maintained in a clean and sanitary condition; human hair was found all over the work carts and clean contact equipment was not stored in covered containers.

## CONCLUSIONS OF LAW

By the conduct referred to in the paragraphs above, Jose Sanchez, d/b/a Supreme Clientele Hair Studio, has violated Wis. Stats. sec. 454.04 (1)(a); 454.08 (1)(b) and Wis. Admin. Code BC 2.04 (1); 2.045 (1); 2.06 (5); 3.02 (1); 4.01 (1) and 4.02 (3a).

## ORDER

1. NOW, THEREFORE, **IT IS HEREBY ORDERED** that Jose Sanchez, d/b/a Supreme Clientele Hair Studio shall pay to the Department of Regulation and Licensing a forfeiture of TWO THOUSAND TWO HUNDRED dollars (**\$2,200.00**). Payment shall be submitted within sixty (60) days from the date of this order. Payment shall be made by **certified check or money order**, payable to the Wisconsin Department of Regulation and Licensing and sent to:

3. **IT IS FURTHER ORDERED** that in the event Jose Sanchez fails to timely submit payment of the forfeiture as set forth above, the establishment license of Supreme Clientele Hair Studio (#80-30131) **SHALL BE SUSPENDED**, without further notice or hearing, until Respondent have complied with the terms of this Order.

This Order shall become effective upon the date of its signing.
