The parties in this matter agree to the terms and conditions of the attached Stipulation as the final decision of this matter, subject to the approval of the Board. The Board has reviewed this Stipulation and considers it acceptable.

Accordingly, the Board in this matter adopts the attached Stipulation and makes the following:

### FINDINGS OF FACT

- 1. Richard J. Freund (DOB: 07/06/44) is duly licensed in the state of Wisconsin as a real estate broker (license #30223). This license was first granted on October 13, 1965.
- 2. Freund's latest address on file with the Department of Regulation and Licensing is 845 S. Main Street Fond Du Lac WI 54935.
- 3. Freund & Associates, LLC, is a licensed real estate business entity which was granted a business entity license (#700040) on December 12, 1996.
- 4. At all times relevant to this action, Richard Freund was the supervising broker and owner of Freund & Associates, LLC.
- 5. From January 1, 1997 through November 25, 1998, Curt W. Mauer worked as a real estate broker fo Freund & Associates, LLC.
- 6. Freund & Associates, LLC had agreed to pay the renewal fees for brokers working for the company. For reasons unknown, Mauer's real estate license was not renewed.
- 7. Richard Freund and Freund & Associates, LLC did not have a system in place for checking the licensure status of the brokers who worked for the company. Respondents were unaware that Mauer's license have expired.
- 8. Mauer worked as a real estate broker for Freund & Associates, LLC., for approximately twenty-three months with an expired license.

## **CONCLUSIONS OF LAW**

The conduct described above constitutes a basis for disciplinary action against the Respondent Richard J. Freund pursuant to Wis. Stats. sec. 452.03 and 452.12 (3)(a).

The conduct described above constitutes a basis for disciplinary action against the Respondent Freund & Associates, LLC., pursuant to Wis. Stats. sec. 452.03 and Wis. Admin. Code RL 17. 07.

#### **ORDER**

NOW, THEREFORE, IT IS HEREBY ORDERED that
