The parties in this matter agree to the terms and conditions of the attached Stipulation as the final disposition of this matter, subject to the approval of the Board. The Board has reviewed this Stipulation and considers it acceptable.

Accordingly, the Board in this matter adopts the attached Stipulation and makes the following:

FINDINGS OF FACT

- 1. **Bonnie J. Slagg** ("Slagg"), date of birth 12/15/56, is licensed in the State of Wisconsin as a Barbering or Cosmetology Manager having license # 81 26775. This license was first granted to her on 04/21/97.
 - 2. Slagg is listed with the Department of Regulation and Licensing as owner of the Barbering and

Cosmetology Establishment d/b/a Bonnie's Beauty Shop, License # 80 26259. The most recent address on file with the Department of Regulation and Licensing for this establishment is 125 W. Fulton St., Edgerton, WI 53534.

- 3. At all times relevant to this action, Slagg was working as owner/manager of record for Bonnie's Beauty Shop. As owner/manager, Slagg was responsible for the daily operations of the establishment and for ensuring that the establishment was in compliance with Wis. Stats. chapter 454 and Admin. Code chapters BC 2, 3 and 4.
- 4. On or about July 19, 2002, an inspection of Bonnie's Beauty Shop was performed by Department of Regulation and Licensing investigator Michelle Krisher. During the inspection investigator Krisher found the following:
 - a. There was no cover on the wastebasket containing hair.
 - b. Hair rollers were not cleaned or disinfected between use.
 - c. Poisonous substances were not stored in a locked cabinet or closet.

CONCLUSIONS OF LAW

- 1. The Wisconsin Barbering and Cosmetology Examining Board has jurisdiction to act in this matter pursuant to sec. 454.15, Wis. Stats.
- 2. The Wisconsin Barbering and Cosmetology Examining Board is authorized to enter into the attached Stipulation pursuant to sec. 227.44(5), Wis. Stats.
 - 3. Respondent **Bonnie J. Slagg** has violated:
 - a. Wisconsin Statutes sec. 454.15(2)(i) and Wisconsin Administrative Code section BC 3.01(4) by not having loose hair removed and placed in a closed container.
 - b. Wisconsin Statutes sec. 454.15(2)(i) and Wisconsin Administrative Code section BC 4.02(3) and BC 4.01(1) by not properly cleaning and disinfecting hair rollers between each use.
 - c. Wisconsin Statutes sec. 454.15(2)(i) and Wisconsin Administrative Code section BC 3.01(6) by not having poisonous substances stored in a locked cabinet or closet.

ORDER

NOW, THEREFORE, IT IS HEREBY ORDERED, that the attached Stipulation is hereby accepted.

IT IS FURTHER ORDERED, that Respondent **Bonnie J. Slagg** shall pay to the Department of Regulation and Licensing a forfeiture of THREE HUNDRED dollars (\$300.00). Payment shall be submitted within thirty (30) days from the date of this order. Payment shall be made by **certified check or money order**, payable to the Wisconsin Department of Regulation and Licensing and sent to: **Department Monitor**, **Division of Enforcement**, **Department of Regulation and Licensing**, **PO Box 8935**, **Madison**, **WI 53708-8935**.

IT IS FURTHER ORDERED, that in the event **Bonnie J. Slagg** fails to timely submit payment of the forfeiture as set forth above, the Barber or Cosmetology Manager's license of **Bonnie J. Slagg** (#81 526775) **SHALL BE SUSPENDED,** without further notice or hearing, until respondent has complied with the terms of this Order.

IT IS FURTHER ORDERED, that file, 02 BAC 058 be, and hereby is, closed.
