The parties in this matter agree to the terms and conditions of the attached Stipulation as the final disposition of this matter, subject to the approval of the Board. The Board has reviewed this Stipulation and considers it acceptable.

Accordingly, the Board in this matter adopts the attached Stipulation and makes the following:

FINDINGS OF FACT

1. **Karen L. Zauft** ("Zauft"), date of birth 09/17/58, is licensed in the State of Wisconsin as a Barbering or Cosmetology Manager having license # 81 18669. This license was first granted to her on 09/12/88.

2. Zauft is listed with the Department of Regulation and Licensing as owner of the Barbering and Cosmetology Establishment, Studio Z Salon, License # 80 21986. The most recent address on file with the Department of Regulation and Licensing for this establishment is 6025 Monona, Dr., Monona, WI 53716.

3. At all times relevant to this action, Zauft was working as manager of record for Studio Z Salon. As owner/manager, Zauft was responsible for the daily operations of the establishment and for ensuring that the establishment was in compliance with Admin. Code chapters BC 2 and 3.

4. On April 18, 2002, Department of Regulation and Licensing investigator Candace Bloedow performed an inspection of Studio Z Salon. During the inspection investigator Bloedow found the following:

- a. Poisonous substances were not stored in a locked cabinet or closet.
- b. A dog was on the premises during business hours.

CONCLUSIONS OF LAW

1. The Wisconsin Barbering and Cosmetology Examining Board has jurisdiction to act in this matter pursuant to sec. 454.15, Wis. Stats.

2. The Wisconsin Barbering and Cosmetology Examining Board is authorized to enter into the attached Stipulation pursuant to sec. 227.44(5), Wis. Stats.

3. Respondents **Karen L. Zauft & Studio Z Salon** have violated:

- a. Wisconsin Administrative Code section BC 3.01(6) by not having poisonous substances stored in a locked cabinet or closet.
- b. Wisconsin Administrative Code sections BC 3.01(10) by having a dog on the premises during business hours.

ORDER

NOW, THEREFORE, IT IS HEREBY ORDERED, that the attached Stipulation is hereby accepted.

IT IS FURTHER ORDERED, that Respondent **Karen L. Zauft** shall pay to the Department of Regulation and Licensing a forfeiture of TWO HUNDRED dollars (\$200.00). Payment shall be submitted within thirty (30) days from the date of this order. Payment shall be made by **certified check or money order**, payable to the Wisconsin Department of Regulation and Licensing and sent to: **Department Monitor, Division of Enforcement, Department of Regulation and Licensing , PO Box 8935, Madison, WI 53708-8935.**

IT IS FURTHER ORDERED, that in the event **Karen L. Zauft** fails to timely submit payment of the forfeiture as set forth above, the Barber or Cosmetology Manager's license of Karen L. Zauft (#81 18669) **SHALL BE SUSPENDED**, without further notice or hearing, until respondent has complied with the terms of this Order.

IT IS FURTHER ORDERED, that file, 02 BAC 025 be, and hereby is, closed.
