The parties in this matter agree to the terms and conditions of the attached Stipulation as the final decision of this matter, subject to the approval of the Board. The Board has reviewed this Stipulation and considers it acceptable.

Accordingly, the Board in this matter adopts the attached Stipulation and makes the following:

FINDINGS OF FACT

1. H. Winston Slater, DDS (DOB 12/06/1955) is duly licensed as a dentist in the state of Wisconsin (license #3381). This license was first granted on 09/14/1984.

2. Dr. Slater's most recent address on file with the Wisconsin Dentistry Examining Board is 400 West Silver Spring Drive, Milwaukee, WI 53217.

3. Dr. Slater's Wisconsin dentistry registration expired effective December 17, 1997. (Dr. Slater had made timely application in 1997 for renewal of his biennial registration, but due to a tax delinquency his renewal could not be processed.)

4. Dr. Slater did not renew his registration again until April 10, 2002. During the period of time between December 17, 1997 and January 11, 2001, Dr. Slater practiced dentistry in Wisconsin without a current license registration. When apprised of the lapse of his license on January 11, 2001, Respondent ceased work as a dentist until his relicensure on April 10, 2002.

5. In resolution of this matter, Dr. Slater consents to entry of the following Conclusions of Law and Order.

CONCLUSIONS OF LAW

By the conduct described above, H. Winston Slater, DDS is subject to disciplinary action against his license to practice dentistry in the state of Wisconsin, pursuant to secs. 440.11(7), 447.03(1) and 447.07, Stats.

ORDER

NOW, THEREFORE, IT IS HEREBY ORDERED that:

1. H. Winston Slater, DDS is REPRIMANDED.

2. Within one (1) year of the date of this Order, Respondent shall submit documentation acceptable to the Board of successful completion of at least thirty (30) hours of community service acceptable to the Board. Community Service shall be pre-approved by the Department Monitor; approval shall be granted only in settings where a system acceptable to the Board exists for verification of hours worked and services provided. Acceptable documentation shall include certification from the sponsoring organization as well as an affidavit executed by Respondent verifying that he performed the community service hours in their entirety. Respondent shall submit for approval an initial proposal for his community service no later than sixty [60] days from the date of this Order.

3. The Department Monitor is the individual designated by the Board as its agent to coordinate all requests for approval of community service. 4. In the event that Respondent fails to fully and timely comply with the terms of this Order, his license to practice dentistry (#3381) **SHALL BE SUSPENDED**, without further notice or hearing, until Respondent has complied with the terms of this Order.

5. This Order shall become effective upon the date of its signing.
