The parties in this matter agree to the terms and conditions of the attached Stipulation, subject to the approval of the Board. The Board has reviewed this Stipulation and considers it acceptable.

In the interest of resolving this matter, Respondent neither admits nor denies the allegations against her and consents to the entry of the following Findings of Fact, Conclusions of Law and Order.

Accordingly, the Board in this matter adopts the attached Stipulation and makes the following:

FINDINGS OF FACT

1. Nancy A. Granlund (D.O.B. 10/22/1956) is duly licensed as a registered nurse in the state of Wisconsin (license #99022). This license was first granted on 04/01/1988.

- 2. Respondent's most recent address on file with the Wisconsin Board of Nursing is N34W23133 Circle Ridge, Pewaukee, WI 53072.
- 3. At all times relevant to this action, Respondent worked as Director of Nursing at River Hills West Health Care Center ["River Hills"], 321 Riverside Drive, Pewaukee, Wisconsin. River Hills is a long-term care facility
- 4. On November 30, 1999, PC, an elderly female resident of River Hills, was seen on rounds by her physician for pain in her left foot. The doctor at that time ordered a physical therapy evaluation. It is unclear from the patient records whether or not the physician ever actually examined PC's foot. Nursing notes show PC's was running a low temperature, and that her white blood cell count was slightly elevated.
- 5. On December 1, 1999 at approximately 6:00 a.m., CD, a licensed practical nurse, checked on the condition of PC. The LPN charted that she was unable to detect a pedal pulse in PC's left foot. She also noted a small bruise on the top of PC's left foot, that her left foot was ruddy colored and that it was slightly cool.
- 6. The information contained in paragraph 5 above was included on the facility's 24-hour Change of Condition report form.
- 7. Respondent was on duty as Director of Nursing at River Hills from December 1, 1999 through December 9, 1999. During that period of time Respondent in addition served as a consultant at another facility.
 - 8. On December 2, 1999 PC's physician issued a telephone order for Duricef to treat PC's foot.
- 9. The charting for PC following December 1, 1999 and continuing on through the morning of December 8, 1999 shows no follow-up assessment of PC's foot that includes a documentation of pedal pulse, an examination for capillary refill, or a comparison of PC's left foot with her right.
- 10. The charting for PC following December 1, 1999 and continuing on through the morning of December 8, 1999 fails to include any documentation of notification to PC's physician of the lack of a pedal pulse in PC's left foot.
- 11. On December 9, 1999, PC was taken to a vascular surgeon at the request of her family. The vascular surgeon who examined PC on December 9, 1999 found no pulse in PC's left foot and observed that PC's left foot was mottled, "ice cold" and "essentially dead."
- 12. In resolution of this matter, Respondent consents to the issuance of the following Conclusions of Law and Order.

CONCLUSIONS OF LAW

- 1. The Wisconsin Board of Nursing has jurisdiction over this matter, pursuant to sec. 441.07, Stats.
- 2. The Wisconsin Board of Nursing is authorized to enter into the attached stipulation, pursuant to sec.

227.44(5), Stats.

3. By the conduct described above, Nancy A. Granlund is subject to disciplinary action against her Wisconsin nursing license, pursuant to sec. 441.07(1), Wis. Stats., and Wis. Admin. Code §§N7.03 (1) and N7.04 (4) and (15).

ORDER

NOW, THEREFORE, IT IS HEREBY ORDERED that Nancy A. Granlund RN (license #99022) is REPRIMANDED.

IT IS FURTHER ORDERED that the Wisconsin nursing license of Nancy A. Granlund (license #99022) is LIMITED as follows:

1. Respondent shall comply with all statutes and code provisions relating to the practice of nursing.

Education/ training Requirement

2. Within one (1) year from the effective date of this Order, Respondent shall submit proof of conducting at least three (3) presentations of nursing staff in-services acceptable to the Board on subject areas pre-approved by the Board as relevant to the findings of this order. The subject areas may include, but are not limited to charting, legal aspects of nursing, and caring for patients with circulatory problems. To be acceptable, a course shall be pre-approved by a member or designated agent of the Board of Nursing. Course presentations shall be at least two [2] hours in length.

In the alternative, Respondent shall submit within six (6) months from the effective date of this Order, documentation of successful completion of at least twelve (12) hours of continuing nursing education approved by the Board in the subject areas of patient charting and legal aspects of nursing and six (6) hours in caring for patients with circulatory problems, or in other areas approved by the Board. To be acceptable, a course shall be pre-approved by a member or designated agent of the Board of Nursing. Acceptable documentation shall include certification from the sponsoring organization as well as a statement signed by Respondent verifying that she attended the course in its entirety.

Department Monitor

3. The Department Monitor is the individual designated by the Board as its agent to coordinate compliance with the terms of this Order, including receiving reports and coordinating all requests for approval of education or other petitions. Termination of limited license status

4. Upon Respondent's full, timely and successful completion of the terms of this Order, the Board shall grant a petition by Respondent to restore her license to full and unrestricted status.

Agency Caregiver Finding

5. If Respondent fails to fully and completely comply with all terms and conditions set forth above or if the Department receives a subsequent credible allegation against Respondent of abuse, neglect or misappropriation, the Department Monitor shall without further notice or hearing notify the Wisconsin Department of Health and Family Services that the findings set forth in this Order shall thereafter constitute an agency finding of neglect for the purposes of secs. 48.685 and 50.065, Wis. Stats. Respondent shall then REFRAIN from any nursing employment in any facility licensed by the Wisconsin Department of Health and Family Services until such time as Respondent successfully completes a rehabilitation review administered by DHFS.

SUMMARY SUSPENSION

6. Violation of any of the terms of this Order may in addition be construed as conduct imperiling public health, safety and welfare and may result in a summary suspension of Respondent's license pursuant to the procedures set forth in Wis. Admin. Code RL Ch. 6. The Board in its discretion may in the alternative impose additional conditions and limitations or other additional discipline for a violation of any of the terms of this Order.

Effective date of Order

7. This Order shall become effective upon the date of its signing.
