A meeting of the State of Wisconsin Pharmacy Examining Board was held on October 8, 2002, during which the board reviewed a petition by Robert V. Guzzetta for the granting of a three month stay of suspension as provided by a *Final Decision and Order* ("*Order*") dated September 13, 1994. (94 PHM 77) and a request by his therapist, that paragraph 2 b (4) of the *Order* be modified to decrease the frequency of drug screening for pemoline to (1) one time per month.

Based upon the board's review of the petition and the supporting documentation presented;

IT IS HEREBY ORDERED: that Robert V. Guzzetta, is granted a three-month stay of the suspension of license #10594 to practice pharmacy in the State of Wisconsin.

IT IS FURTHER ORDERED: that paragraph 2 b (4) of the *Order* is modified to decrease the frequency of drug screening for pemoline to (1) one time per month.
