On July 9, 2002, the State of Wisconsin Pharmacy Examining Board reviewed the documentation submitted in support of the petition by John R. Litzenberg, R.Ph., for a three month extension of the stay of suspension, as provided within the board's *Final Decision and Order* ("*Order*") dated August 12, 1998, and that he be allowed to work an additional eight (8) hours per week as a pharmacist in charge. Litzenberg currently is entitled to work a maximum of twenty-four (24) hours per week as a pharmacist in charge. Litzenberg also petitioned to modify the board order dated April 10, 2001, which provided in part, "The request for termination of controlled substances audits is granted in part with the limitation that he cannot discontinue the controlled substances audit at his primary work site, but he does not have to perform the controlled substances audit at other Walgreen locations as long as his work at such other Walgreen locations does not exceed 40 hours per month." Litzenberg sought to increase the hour limit contained in the April 10, 2001, order to (50), fifty. Based upon the foregoing:

IT IS HEREBY ORDERED that John R. Litzenberg, R.Ph., is GRANTED a three month stay of the suspension of license number 10410 to practice pharmacy in the State of Wisconsin and that the request to work an additional eight (8) hours per week as a pharmacist in charge is GRANTED for a total of (32) thirty two hours per week, restricted to his employer, Walgreens.

IT IS FURTHER ORDERED the board order dated April 10, 2001, is modified such that Litzenberg cannot discontinue the controlled substances audit at his primary work site, but he does not have to perform the controlled substances audit at other Walgreen locations as long as his work at such other Walgreen locations does not exceed 50 hours per month.
