On Janaury 8, 2002, the State of Wisconsin Pharmacy Examining Board reviewed the documentation submitted in support of the petition by Craig W. Moon, R.Ph., for a three month stay of suspension as provided within the board's *Final Decision and Order* ("*Order*") dated August 12, 1998, and that the required monthly urine screens currently set at six (6) be reduced to four (4).

Based upon the board's review:
