On July 9, 2002, the State of Wisconsin Pharmacy Examining Board reviewed the documentation submitted in support of the petition by Craig W. Moon, R.Ph., for a three month stay of suspension as provided within the board's *Final Decision and Order* ("Order") dated August 12, 1998, and that his individual/group therapy sessions currently set at (1x), once, per month by board order dated October, 1999, be reduced to quarterly, and that his hours permitted to practice as a pharmacist in charge, currently set at (24), twenty four, by board order dated July, 2001, be increased within the board's discretion, and that he be allowed to open and close the pharmacy.

Based upon the board's review:

IT IS HEREBY ORDERED, that the petition of Craig W. Moon, R.Ph., for a three month stay of suspension of license number 10536 is granted.

IT IS FURTHER ORDERED, that the petition for an increase in hours permitted to practice as a pharmacist in charge is granted in the amount of (8) eight hours, for a total of (32), thirty two hours. Moon may open and close the pharmacy but not consecutively, except for every fourth weekend.

IT IS FURTHER ORDERED that the petition to reduce the individual/group therapy sessions currently set at (1x), once, per month by board order dated October, 1999, is granted, and hereby reduced to quarterly.
