James A. Meyer, R.Ph., is currently practicing pharmacy subject to the terms of the board's Final Decision and Order ("Order") dated November 10, 1998, LS 9811105PHM. (As modified by an Order dated June 13, 2001). At its November 12, 2002, meeting, the board was presented with information provided by the department monitor, Marlene Meyer, that she was informed by Dr. Charles Engel, MD, of Professional Recovery Network, (PRN), by telephone on that date that James Meyer is currently admitted to in-patient treatment at the Herrington Center, from October 31, 2002. His projected release date is the end of November, 2002. Mr. Meyer is currently being treated for relapse related to the diversion of Adderall. Dr. Engel further informed the department monitor that Mr. Meyer was scheduled for urine drug screening during the time period seven days prior to his being admitted to the Herrington Center on October 31, 2002, however, did not appear to provide a sample. Therefore, no urine screens during that time period are available for the board's review. The board also reviewed correspondence from Dr. Engel, dated November 8, 2002, generally reporting Mr. Meyer's relapse status.

Based upon the board's review and consideration of the above facts:

IT IS HEREBY ORDERED: that the license of James A. Meyer, R.Ph., #11446, to practice pharmacy in the State of Wisconsin is SUSPENDED.
