On December 10, 2002, the State of Wisconsin Pharmacy Examining Board reviewed the documentation submitted in support of the petition by Ralph G. Koch, R.Ph., for a three-month extension of the stay of suspension, as provided within the board's *Final Decision and Order* ("Order") dated June 16, 1999. Koch also requested that paragraph 2c(2) of the Order, restricting Koch from practicing as a managing pharmacist, be deleted from the Order. Koch also requested that the individual/group therapy required by paragraph 2b(2) be reduced to one time (1x) every six (6) months, and that paragraph 2b(4) of the Order be modified to provide for drug screening at the frequency of one (1) urine drug screen and one (1) breath test for alcohol per month. Based upon the board's review, IT IS HEREBY ORDERED:

- 1) That Ralph G. Koch, R.Ph., is granted a three-month stay of the suspension of license #9023 to practice pharmacy in the State of Wisconsin.
- 2) The petition that paragraph 2c(2) of the *Order*, restricting Koch from practicing as a managing pharmacist, be deleted from the *Order*, is granted.
- 3) The petition that the individual/group therapy required by paragraph 2b(2) of the *Order* be reduced to one time (1x) every six (6) months, is denied.
- 4) The petition that paragraph 2b(4) of the *Order* be modified to provide for drug screening at the frequency of one (1) urine drug screen and one (1) breath test for alcohol per month, is denied.
