On January 8, 2002, the State of Wisconsin Pharmacy Examining Board reviewed the petition by Ralph G. Koch, R.Ph., for removal of the prohibition against Koch working as a managing pharmacist, pursuant to (paragraph 2.c.(2)) of board's *Final Decision and Order* ("Order") dated June 16, 1999. The board denied the petition at that time. On July 9, 2002, the board once again reviewed a petition by Koch for removal of the prohibition against Koch working as a managing pharmacist, pursuant to (paragraph 2.c.(2)) of the *Order*.

Based upon the board's review:

IT IS HEREBY ORDERED that the petition for removal of the prohibition against Koch working as a managing pharmacist, (paragraph 2.c.(2)) of the *Order*, is denied.
