On March 12, 2002, the State of Wisconsin Pharmacy Examining Board reviewed the documentation submitted in support of the petition by Cory S. Ford, R.Ph., for a three-month extension of the stay of suspension, as provided within the board's *Final Decision and Order* ("*Order*") dated March 10, 1999, and a request to modify the *Order* to discontinue group therapy on a biweekly basis.

Based upon the board's review,

IT IS HEREBY ORDERED that Cory S. Ford, R.Ph., is granted a three-month stay of the suspension of license #11082 to practice pharmacy in the State of Wisconsin.

IT IS FURTHER ORDERED that the request for modification of the individual/group therapy requirements of paragraph 2b(2) of the *Order* is granted and Ford shall attend individual therapy with his counselor on a monthly basis.
