On June 12, 2002, the State of Wisconsin Pharmacy Examining Board reviewed the documentation submitted in support of the petition by Cory S. Ford, R.Ph., for a three-month extension of the stay of suspension, as provided within the board's *Final Decision and Order* ("*Order*") dated March 10, 1999, and a request to modify the *Order* to increase the number of hours worked per week as a pharmacist in charge. Ford currently works (8) eight hours per week as a pharmacist in charge.

Based upon the board's review,

IT IS HEREBY ORDERED that Cory S. Ford, R.Ph., is granted a three-month stay of the suspension of license #11082 to practice pharmacy in the State of Wisconsin.

IT IS FURTHER ORDERED that the request for modification of the *Order* is granted and Ford is granted an additional (8) eight hours per week to work as a pharmacist in charge, for a total of (16) sixteen hours. Ford may not open or close the pharmacy.
