On June 12, 2002, the State of Wisconsin Pharmacy Examining Board reviewed supporting documentation submitted on behalf of a petition by Kevin M. Pampuch for an order modifying the *Final Decision and Order* ("Order") in the above-captioned matter entered on March 10, 1999, to allow Pampuch to work up to (8) eight hours per day as a pharmacist in charge. It was contemplated by Pampuch that the hours worked would be in the evening shift. Based upon a review of the petition and the documents submitted in support thereof the board ordered on June 12, 2002, to allow Kevin Pampuch to work up to (8) eight hours per day as a pharmacist in charge for a trial period of two (2) months. The board further ordered that during the next two months of July or August, 2002, Pampuch and his work supervisor should appear before the board to report regarding Pampuch's work performance under the trial period to allow the board to evaluate whether to extend the trial period on terms within the board's discretion. On July 9, 2002, Pampuch and his supervisor, Bill Herbert, at his place of employment, Meriter Hospital, appeared before the board as directed. Based upon the above and the testimony provided by Mr. Pampuch and Bill Herbert:

IT IS HEREBY ORDERED, that the *Order* is modified to allow Kevin Pampuch to work up to (8) eight hours per day as a pharmacist in charge, including the night shift, restricted to his employer, Meriter Hospital.

IT IS FURTHER ORDERED, that Kevin Pampuch be granted a three month stay of suspension of license number 12635 to practice pharmacy in the State of Wisconsin.
