On June 12, 2002, the State of Wisconsin Pharmacy Examining Board reviewed the documentation submitted in support of the petition by William Karwoski, R.Ph., for a three-month extension of the stay of suspension as provided within the board's *Final Decision and Order* ("Order") dated March 10, 1999.

Based upon the board's review,

IT IS HEREBY ORDERED that William Karwoski, R.Ph., is granted a three-month stay of the suspension of license #9334 to practice pharmacy in the State of Wisconsin.

IT IS FURTHER ORDERED that in all other respects, the previous orders of the board in this matter remain in full force and effect. Mr. Karwoski is advised that he must comply with the original terms of the *Order* following the resumption of the practice of pharmacy, and must repetition the board for any modifications to the original terms of the *Order* following the resumption of the practice of pharmacy.
