ORDER REINSTATING FULL LICENSURE

On June 23, 1999, the Medical Examining Board issued its Final Decision and Order in the above-captioned matter. By the terms of the board's order, respondent's license to practice medicine and surgery in Wisconsin was limited to require that remain in full compliance with a disciplinary order issued by the Minnesota Board of Medical Practice.

On October 23, 2002, the board considered Dr. Swanson's petition for reinstatement of his full license based upon a similar order issued by the Minnesota board. Based upon all evidence of record herein, the board orders as follows:

ORDER

NOW, THEREFORE, IT IS ORDERED that all limitations on the license of David A. Swanson, M.D., to practice medicine in the State of Wisconsin are terminated, and Dr. Swanson is hereby reinstated to full licensure.
