On September 6, 2000, the Dentistry Examining Board issued its Final Decision and Order in the above-captioned matter. By the terms of the Board's Order, Respondent's license was limited, and he was ordered to complete, *inter alia*, an education program administered by the Marquette University School of Dentistry. The Order further provided that Dr. Gloyeck's practice be monitored for a one-year period following his successful completion of the educational program. It also provided that upon a showing by Respondent of compliance with the conditions of the Order that he would be eligible for the return of his full license.

On May 1, 2002, the Board considered A. William Gloyeck's request that the limitations on his license be terminated. Based upon that request and upon evidence of Dr. Gloyeck's compliance with the terms and conditions on his license,

NOW, THEREFORE, IT IS HEREBY ORDERED that all the limitations on the license of A. William Gloyeck to practice as a dentist in Wisconsin are lifted and he is restored to full licensure.
