An informal settlement conference was conducted in the above-captioned matter before the Board of Nursing on July 8, 1999. Based upon the proceedings at the conference, and upon the Stipulation of the parties, the board entered its Order by which Ms. Harris-Bell's license was limited to require that she complete continuing education in the use of central venous catheters; and that she be responsible for submission of quarterly written work reports prepared by her nursing employer describing Ms. Harris-Bell's activities and progress in her nursing employment.

On February 1, 2002, the board considered evidence that Ms. Harris-Bell has completed the requirements of her limited license. Accordingly, it is ordered as follows:

ORDER

NOW, THEREFORE, IT IS ORDERED that all limitations on the license of Linda Harris-Bell, RN, to practice as a professional nurse in Wisconsin are terminated, and Ms. Harris-Bell is hereby reinstated to full licensure.
