On September 17, 1999, the Board of Nursing issued its Final Decision and Order in the above-captioned matter. By the terms of the board's order, respondent's license to practice as a registered nurse in Wisconsin was limited to place restrictions on her practice, including requirements that she complete continuing education, and provide work reports from her employer.

On April 4, 2002, the board considered evidence that Ms. Dela Cruz has fully complied with the requirements of her limited license for the requisite period of time. Accordingly, it is ordered as follows:

ORDER

NOW, THEREFORE, IT IS ORDERED that all limitations on the license of Luz Bella Dela Cruz, RN, are terminated, and Ms. Dela Cruz is hereby reinstated to full licensure.
