On December 10, 2002, the State of Wisconsin Pharmacy Examining Board reviewed the petition of Andrew P. Rice, R.Ph., for a three-month stay of suspension, as provided within the board's *Final Decision and Order* ("*Order*") dated September 21, 1999, and that the requirement for individual/group therapy as required by paragraph 2b(2) of the *Order* be removed. No therapist or doctor documentation was submitted in support of the petition for a three month stay of suspension or to remove the requirement of individual/group therapy.

Based upon the board's review,

IT IS HEREBY ORDERED that Andrew P. Rice, R.Ph., is granted a one month stay of the suspension of license #9594 to practice pharmacy in the State of Wisconsin.

IT IS FURTHER ORDERED that the petition to remove the requirement for individual/group therapy as required by paragraph 2b(2) of the *Order*, is denied.

IT IS FURTHER ORDERED that if Rice shall petition a subsequent three month stay of suspension he shall cause to have submitted on his behalf the required therapist reports in support of the petition, as required by the *Order*.
