On April 17, 2002, the Wisconsin Psychology Examining Board issued a limited license to practice psychology in the State of Wisconsin to Jeremy D. Meyers, requiring him to practice under supervision until his supervisor was able to certify that Dr. Meyers had obtained sufficient supervised experience to practice independently in one or more areas. Dr. Meyers has been receiving supervision from Dr. John Ivanoff.	
In a letter dated January 23, 2003, Dr. Ivanoff stated his opinion that Mr. Meyers is capable of practicing independently as an assessment psychologist. Therefore,	
IT IS ORDERED that the limitations placed on the license to practice psychology issued to Jeremy D. Meyers are hereby removed and Dr. Meyers will be issued an unlimited license.	
Dr. Meyers's independent practice will be restricted, as is that of all licensed psychologists, to the "Nature of Intended Practice of Psychology" form that he has already filed with the board. Dr. Meyers's form states that his specialty area is "Industrial/Organizational Psychology"; the general services he is qualified to provide are "Evaluation" and "Consultation"; the specialized service he is qualified to provide is "Competency Evaluation", and the population he is qualified to serve is "Adults (18 and over)". To practice independently in any other area, Dr. Meyers must obtain additional supervised experience and file a revised "Nature of Intended Practice of Psychology" form for the board's review and approval.
