### ORDER REINSTATING FULL LICENSURE

On July 12, 2000, applicant filed his application for a license to practice as a respiratory care practitioner in Wisconsin. On his application, applicant submitted information indicating that he had been convicted on three occasions for battery, and was currently on probation for the last of these.

The board considered the matter at its meeting of February 21, 2001, and applicant and the board thereafter entered into a Stipulation by which the board agreed to issue, and Mr. Le Van agreed to accept, a limited license requiring that he complete all conditions of probation imposed by Milwaukee Circuit Court Branch 7 in Case # 99CM010389, including successful completion of the required anger management course. Upon successful completion of probation, and submission of satisfactory evidence thereof, applicant was permitted to petition for removal of all limitations on his license.

On December 17, 2003, the board considered Mr. Le Van's petition for termination of all limitations on his license. Based upon all information of record herein, the board orders as follows:

### <u>ORDER</u>

NOW, THEREFORE, IT IS ORDERED that all limitations on the license of Joseph Le Van, RCP, are terminated, and Mr. Le Van is hereby reinstated to full licensure.
