ORDER DENYING STAY

On July 7, 1995, the Board of Nursing issued its Final Decision and Order in the above-captioned matter, by which respondent's license to practice as a registered nurse in Wisconsin was suspended for an indefinite period. Under the terms of the Order, the suspension of Ms. Livesey's license was stayed for three months, with provision for successive three-month stays of the suspension conditioned upon compliance with certain conditions and limitations on the license. Among these were that respondent participate in a recognized program for the treatment of chemical dependency, that she participate in psychotherapy a minimum of four times each month, and that she participate in program of random witnessed monitoring for controlled substances and alcohol in her blood or urine on a frequency of not less than four times per month.

By its Order dated December 1, 1995, the board imposed the suspension of Ms. Livesey's license based upon her notification to the board that she chose not to seek renewal of the stay of the suspension.

On July 7, 2000, the board considered Ms. Livesey's letter of May 25, 2000, requesting reinstatement of her license. The board reinstated the stay by its Order dated July 19, 2000. The license was limited to require that she utilize it exclusively for the purpose of completing a nurse refresher course.

On February 2, 2001, the board considered evidence that Ms. Livesey had not complied in any particular with the requirements of her limited license, and has not requested a further stay of the suspension. The board therefore suspended the license.

On October 4, 2002, the board granted Ms. Livesey's request that the stay be reinstated. The Order provided that Ms. Livesey's license could be utilized exclusively for the purpose of completing the R.N Nursing Update Course at Waukesha County Technical College. Upon submission of evidence of satisfactory completion of the R.N. Nursing Update Course, Ms. Livesey's license was ordered to be subject to the conditions and limitations set forth in the board's Final Decision and Order dated July 7, 1995.

On January 10, 2003, the board considered the grant of a further three month stay of the suspension. The board also considered that Ms. Livesey had never renewed her license and had not requested a further stay. Accordingly, it is ordered as follows:

ORDER

NOW, THEREFORE, IT IS ORDERED that the stay of suspension of the license of Treiva Livesey is terminated, and her license and any right to renew the license is hereby suspended.
