On April 9, 2003, the State of Wisconsin Pharmacy Examining Board reviewed the documentation submitted in support of the petition by Mark G. Anderson, R.Ph., for a three month stay of suspension a required by the board's *Final Decision and Order*, ("*Order*") dated August 9, 2000. Also requested was a modification that would reduce the twice per year controlled substance audits, as required by paragraph 2c(7) of the *Order*, to once per year.

Based upon the board's review of the respondent’s petition and the documents submitted therewith;

IT IS HEREBY ORDERED: that Mark G. Anderson, R.Ph., is granted a three-month stay of the suspension of license #9189 to practice pharmacy in the State of Wisconsin.

IT IS FURTHER ORDERED: The request to modify paragraph 2c(7) of the *Order* to reduce the twice per year controlled substance audits to once per year, is denied.
