ORDER GRANTING STAY

On March 30, 2000, the Board of Nursing issued its Final Decision and Order in the above-captioned matter. By the terms of the board's order, respondent's license to practice as a registered nurse in Wisconsin was suspended for an indefinite period, with provision for successive three-month stays of the suspension conditioned upon compliance with certain conditions and limitations on the license. Among these were that respondent participate in a recognized program for the treatment of chemical dependency, that she participate in psychotherapy a minimum of once per week, and that she participate in program of random witnessed monitoring for controlled substances and alcohol in her blood or urine on a frequency of not less than once per week.

On September 1, Ms. Hanaman appeared before the board in support of her request for a further three month stay of the suspension of her license. The board on that date denied the stay and specified that Ms. could make a further request for a stay to be considered by the based upon satisfactory evidence that Ms. Hanaman has been fully compliant with the board's March 30, 2000, Order.

On January 3, 2002, Ms. Hanaman appeared in support of her further request for a stay of the suspension of her license. Based upon evidence that Ms. Hanaman had failed to come into compliance with the limitations on her license, the board denied the stay by its Order dated January 19, 2002.

On March 1, 2002, the board denied Ms. Hanaman's further request for a stay of the suspension based upon her failure to submit to the minimum number of urine screens.

On April 4, 2002, the board again considered a request by Ms. Hanaman that the suspension of her license be stayed, and again the board was confronted with evidence that Ms. Hanaman was still not in compliance with the board's Order, in having failed to submit to the minimum number of urine screens. Accordingly, the stay was denied.

On September 5, 2003, the board considered Ms. Hanaman's renewed request for reinstatement of the stay. Based upon all information of record herein, the board orders as follows:

ORDER

NOW, THEREFORE, IT IS ORDERED that Ms. Hanaman's request for a stay of the suspension of her license is granted, and the suspension is hereby stayed for a period of three months.
