On June 19, 2003, the State of Wisconsin Pharmacy Examining Board reviewed the documentation submitted in support of the petition by Thomas M. Triscari, R.Ph., for a three-month extension of the stay of suspension of his license to practice pharmacy in the State of Wisconsin, as provided within the board's *Final Decision and Order* ("Order") dated May 17, 2000. Also requested by his physician, Charles J. Engel, in correspondence dated April 24, 2003, was an increase in the hours worked as a pharmacist in charge from the "current" 12 to 16 hours per week. By correspondence dated May 7, 2003, Triscari's employer also indicated that Triscari has not worked more than 12 hours per week and the employer requests additional hours be granted. Triscari, by correspondence dated May 12, 2003, requests an "additional 4 to 8 hours" per week as a pharmacist in charge, but Triscari does not indicate how many authorized hours he believes he currently has. By order dated September 10, 2002, Triscari was granted 16 hours per week to work as a pharmacist in charge.

Based upon the board's review:

IT IS HEREBY ORDERED that Thomas M. Triscari, R.Ph., is granted a three-month stay of the suspension of license #10029 to practice pharmacy in the State of Wisconsin.

IT IS FURTHER ORDERED that the request for additional hours to be granted as a pharmacist in charge is DENIED as moot, as Triscari has been previously authorized for the amount requested.
