ORDER GRANTING STAY

On January 4, 2001, the Board of Nursing issued its Final Decision and Order in the above-captioned matter. By the terms of the board's order, respondent's license to practice as a registered nurse in Wisconsin was suspended for an indefinite period, with provision for successive three-month stays of the suspension conditioned upon compliance with certain conditions and limitations on the license. Among these were that respondent participate in a recognized program for the treatment of chemical dependency, that he participate in psychotherapy a minimum of once each week, and that he participate in program of random witnessed monitoring for controlled substances and alcohol in his blood or urine on a frequency of not less than once each week.

On May 3, 2001, the board considered evidence that respondent had failed to submit evidence of having complied with any of the limitations on his license. Accordingly, the board terminated the stay by its Order dated May 15, 2001.

On August 2, 2001, the board considered Mr. Dziatikiewicz' request for reinstatement of the stay of suspension, and his further request that he be granted access to controlled substances. The board granted the stay, but denied access to controlled substances.

On December 6, the board considered Mr. Dziatikiewicz' request for a further three month stay of the suspension, and renewal of his request that he be permitted access to controlled substances in his employment setting. The board granted both requests by its Order dated December 18, 2001.

On March 1, the board granted Mr. Dziatikiewicz' request for a further three month stay of the suspension.

On April 4, 2002, the board considered evidence that Mr. Dziatikiewicz was in violation of the board's Order in having failed or refused to submit to a urine screen and in appearing at his place of employment while impaired. The board therefore ordered that the stay of suspension be terminated.

On May 9, 2003, the board considered Mr. Dziatikiewicz' request for reinstatement of the stay. Based upon all information of record herein, it is ordered as follows:

ORDER

NOW, THEREFORE, IT IS ORDERED that the suspension of the license of Lee Allen Dziatikiewicz, RN, is stayed for a period of three months. Mr. Dziatikiewicz may petition for further stays, and such petitions shall be granted upon demonstration of full compliance with the board's order during the previous three months.
