On January 10, 2001, the State of Wisconsin Department of Regulation and Licensing entered a *Final Decision and Order*, ("*Order*") in case number LS0101101RSG. The *Order* provided in part that the respondent's private detective agency license, number 15540, was limited in that for a period of two years commencing from January 10, 2001, the respondent was to submit quarterly reports to the department providing a true and accurate accounting of the names and addresses of all employees employed by the respondent as security guards, the dates of hire, private security license numbers and the dates of security guard work performed by each employee. On January 24, 2003, the department monitor received the final quarterly report due under the *Order*. All remaining requirements of the *Order* have been satisfied.

Accordingly,

IT IS HEREBY ORDERED that an unlimited private detective agency license (#15540) be and hereby is restored to Response Security, Inc.
