On November 11, 2003, the State of Wisconsin Pharmacy Examining Board reviewed the documentation submitted in support of the petition by Luigi N. Miceli, R.Ph., for a three month stay of suspension to be granted on his license to practice pharmacy in the state of Wisconsin as provided in the board's *Final Decision and Order* dated October 10, 2001. ("*Order*") and that paragraph 2.c.(3) of the *Order* be modified allowing him to be employed as a pharmacist in charge for a total of ten hours per week. .

Based upon a review of the petition and supporting documentation submitted:

IT IS HEREBY ORDERED: that Luigi N. Miceli, R.Ph., is granted a three month stay of the suspension of license #10794 to practice pharmacy in the State of Wisconsin.

IT IS FURTHER ORDERED that request for modification of paragraph 2.c.(3) of the *Order*, is granted for a total of (8), eight, hours per week to be worked as a pharmacist in charge.
