ORDER GRANTING STAY AND MODIFYING CONDITIONS
On March 1, 2002, the Board of Nursing issued its Final Decision and Order in the above-captioned matter. By the terms of the board's order, respondent's license to practice as a practical nurse in Wisconsin was suspended for an indefinite period. The Order provided that respondent could request that the suspension of his license be stayed for a period of three months upon submission of evidence that respondent could safely practice as a practical nurse by submission of a satisfactory evaluation prepared by a health care provider acceptable to the coard. The Order also provided that respondent could thereafter request additional three month stays of the suspension, which would be granted upon submission of evidence of his compliance with the terms and conditions on the license. Included among these were that respondent participate in an approved drug and alcohol creatment program if recommended by the evaluator, and that he participate in a drug screening program consisting of at least 52 screens per year. The Order also required that Mr. Schober pay the costs of the proceeding by July 6, 2002.
On March 13, 2001, and May 16, 2002, the board granted Mr. Schober's requests for three month stays of the suspension of her license.
On July 11, 2002, the board granted Mr. Schober's request to permit her to pay the costs in installments of six monthly payments of \$200 and a payment on the seventh month of \$171.43.
On September 5, 2002, the board considered Mr. Schober's request for a further stay of the suspension. The board also considered evidence that Mr. Schober had not fully complied with the required urine screens. The board therefore denied the stay
On October 5, 2002, the board granted Mr. Schober's request that the stay be reinstated.
On December 17, 2002, the board granted Mr. Schober's request for a further three month stay.

On April 4, 2003, the board considered Mr. Schober's request for a further stay of the suspension, and his further request that the number of required urine screens be reduced. The board also considered information that Ms. Schober had failed to submit to the minimum number of urine screens in September, 2002. The board granted the stay but denied a reduction in screens.

On October 3, 2003, the board considered Mr. Schober's request for a three month stay, and renewal of his request for a reduction in the number of required urine screens. Based upon all information of record herein, the board orders as follows:

ORDER

On July 11, 2003, the board granted Mr. Schober's request for a further three month stay.

NOW, THEREFORE, IT IS ORDERED that the request of Lynn Schober for a further stay of the suspension of his license is granted, and the suspension is hereby stayed for a period of three months.

IT IS FURTHER ORDERED that the request for a reduction in the number of required urine screens is granted, and the number of required urine screens is hereby reduced to 10 per quarter.
