On November 4, 2001, the board entered its Final Decision and Order in the above-captioned matter. By the terms of the board's Order, Dr. Levin's license to practice medicine and surgery was limited for one year or until his community service obligation contained in the board's Order was completed.

Dr. Levin was to provide no fewer than 160 hours of uncompensated community service (which could consist of providing clinical medical services to indigent patients in an established program for providing such services) as approved by the Board or its designee.

On January 22, 2003, the board considered Dr. Levin's petition to reinstate him to full licensure, and he appeared before the board in support of his petition.

Based upon all information of record herein, the board orders as follows:

### ORDER

NOW, THEREFORE, IT IS ORDERED that all limitations on the license of Allan B. Levin, M.D. are terminated, and Dr. Levin is hereby reinstated to full licensure.
