On June 3, 2003, the Wisconsin Dentistry Examining Board reviewed the documentation submitted in support of the request by Blair D. Moldenhauer, D.D.S., for a three-month stay of suspension, as provided in the Board's *Final Decision and Order* dated January 9, 2002. The Board issued a three-month stay to Dr. Moldenhauer at its March 2003 meeting and further ordered him to submit the name of a treatment provider for the Board's approval prior to its next meeting. Dr. Moldenhauer did not submit the name of a treatment provider to the Board. Instead, he provided a report from an unapproved provider, which was not in compliance with the Board's Order.

Therefore, based upon the Board's review,

IT IS HEREBY ORDERED that Blair D. Moldenhauer, D.D.S., is granted a stay of the suspension of License #015-33331 to practice dentistry in the State of Wisconsin until July 2, 2003.

IT IS FURTHER ORDERED that Dr. Moldenhauer shall personally appear before the Board at its July 2, 2003 meeting.

Please be advised that the next submission of reports and the petition for an extension of a stay of suspension are due on June 18, 2003.
