On December 18, 2003, and March 19, 2003, the board granted Dr. Strick's petitions for further stays of the suspension of his license.

On June 18, 2003, the board granted Dr. Strick's request for a further three month stay of the suspension, but denied his further request that he be permitted to apply for and hold a DEA registration.

On July 23, 2003, the board considered Dr. Strick's renewal of his request that he be permitted to apply for and hold a DEA registration. The board notes that Dr. Strick's Order has been in effect for less than one year. Accordingly, it is ordered as follows:

NOW, THEREFORE, IT IS ORDERED that Dr. Strick's request that he be permitted to apply for and hold a DEA registration is denied.
