On March 11, 2003, the State of Wisconsin Pharmacy Examining Board reviewed supporting documentation submitted on behalf of a petition by Mr. Oestreich for an order granting a stay of suspension pursuant to the *Final Decision and Order* ( "*Order*") in the above-captioned matter entered on December 10, 2002.

IT IS HEREBY ORDERED that Duane A. Oestreich, is granted a one-month stay of the suspension of license #8131 to practice pharmacy in the State of Wisconsin.

Oestreich will cause to have submitted to the board for consideration its next regularly scheduled meeting on April 8, 2003, the following; an explanation by his supervising physician regarding Mr. Oestreich's positive urine screens for hydrocodone and benzodiazepines, and copies of all prescriptions for controlled substances written for Mr. Oestreich from December 10, 2002, to the present.
