- 2. On exact dates unknown, but at least between August 1, 2002 and January 14, 2003, respondent worked as a registered nurse at Heartland of Milwaukee Nursing Home, 3216 West Highland Boulevard, Milwaukee, Wisconsin.
  - 3. Ms. Cloyd understands that she needs a license to practice nursing in the state of Wisconsin. In
