Accordingly, the Board in this matter ac	dopts the attached Stipulation and makes the following:
	FINDINGS OF FACT

1. Respondent Charles E. Hall, R.Ph. (d.o.b. 11/23/44) is and was at all times relevant to the facts set forth herein a registered pharmacist licensed in the state of Wisconsin pursuant to license # 7976, originally granted April 3, 1970. At all times relevant to this action, Mr. Hall was the owner and managing pharmacist of Hall

Pharmacies, Inc., Sauk City, Wisconsin.

- 2. On April 23, 2002, MB went to the Hall pharmacy to have two prescriptions filled, one for Nasacort AQ inhaler and one for Triamcinolone lotion. A clerk printed the labels and affixed them each to the wrong container. The clerk then dispensed the prescriptions to the customer. There was no consultation or contact with a pharmacist.
- 3. By order dated 10/10/2001, in case 01 PHM 021, Respondent was disciplined for allowing an unlicensed person to transfer prescriptions to two patients, and for failure to provide consultations.
- 4. Respondent was previously disciplined on 04/14/92, in case 87 PHM 069, for controlled substance handling and recordkeeping violations.

CONCLUSIONS OF LAW

- A. The Wisconsin Pharmacy Examining Board has jurisdiction to act in this matter pursuant to §450.10, Wis. Stats. and is authorized to enter into the attached Stipulation pursuant to §227.44(5), Wis. Stats.
- B. The conduct described in paragraph 2, 3 and 4 above, violated § 450.10(1)(a)(6) Stats., and Phar. 7.01(1)(d) and (e), and 10.03(2) Wis. Adm. Code. Such conduct constitutes unprofessional conduct within the meaning of the code and statutes.

ORDER

NOW, THEREFORE, IT IS HEREBY ORDERED, that the attached Stipulation is accepted.

IT IS FURTHER ORDERED, that, Charles E. Hall, R.Ph., is REPRIMANDED for his unprofessional conduct in this matter.

IT IS FURTHER ORDERED, that Respondent shall pay a FORFEITURE in the sum of

\$ 2,000.00, and COSTS in this matter in the amount of \$ 400.00, within 30 days of this order to the Department of Regulation and Licensing.

IT IS FURTHER ORDERED, that an investigator of the department shall observe the practice of pharmacy at Respondent's practice location, without advance notice to respondent, at a time convenient to the department, but no less than six nor more than twelve months from the date of this Order. Respondent shall cooperate by furnishing respondent's work schedule upon request.

IT IS FURTHER ORDERED, that pursuant to §227.51(3), Wis. Stats., and ch. RL 6, Wis. Adm. Code, if the Board determines that there is probable cause to believe that Respondent has violated any term of this Final Decision and Order, the Board may order that the license of respondent be summarily suspended pending investigation of the alleged violation.
