The parties in this matter agree to the terms and conditions of the attached Stipulation as the final disposition of this matter, subject to the approval of the Board. The Board has reviewed this Stipulation and considers it acceptable.

Accordingly, the Board in this matter adopts the attached Stipulation and makes the following:

FINDINGS OF FACT

1. **Robyn L. Cammack** ("Cammack"), date of birth 3/31/48, is licensed in the State of Wisconsin as a real estate salesperson having license # 94-31049. This license was first granted to her on 05/19/89. Cammack's most recent address on file with the Department of Regulation and Licensing is, 11158 N. Sun-N-Sno Rd., Hayward, WI 54843.

2. On January 1, 1995, Cammack's Wisconsin real estate salesperson license expired and was not renewed until October 7, 1999.

3. At all times relevant to the facts, Cammack was a real estate salesperson employee of Century 21 Northern States Realty, PO Box 1229, Hayward, WI 54843.

4. Century 21 Northern States Realty, Wisconsin license # 91-835217, expired January 1, 2001, and has not been renewed to date. Century 21 Northern States Realty is no longer doing business in the state of Wisconsin.

5. At all times relevant to the facts, Bradley S. Lamp ("Lamp"), license # 90-47585, was the real estate Broker /Owner of Century 21 Northern States Realty. Lamp's most recent address on file with the Department of Regulation and Licensing is PO Box 75841, St. Paul, MN 55175. Lamp's Wisconsin Real Estate Broker's license expired January 1, 2001, and has not been renewed to date. Lamp is no longer doing business in the state of Wisconsin.

6. Cammack admits that during the time her Wisconsin Real Estate Salesperson's license was expired (January 1, 1995 through October 7, 1999) she was engaged in real estate sales.

CONCLUSIONS OF LAW

1. The Wisconsin Real Estate Board has jurisdiction to act in this matter pursuant to sec. 452.14, Wis. Stats.

2. The Wisconsin Real Estate Board is authorized to enter into the attached Stipulation pursuant to sec. 227.44(5), Wis. Stats.

3. Respondent **Robyn L. Cammack** has violated:

a. Wis. Adm. Code sec. RL 24.17(3), Wis. Stats. sec. 452.03, Wis. Stats. sec. 452.14(3)(L) and Wis. Stats. sec. 452.14(3)(i) by practicing real estate without having a valid Wisconsin real estate license between January 1, 1995, and October 7, 1999.

ORDER

NOW, THEREFORE, IT IS HEREBY ORDERED, that the attached Stipulation is hereby accepted.

IT IS FURTHER ORDERED, that Respondent **Robyn L. Cammack**, license #94-31049, be, and hereby is, **REPRIMANDED**.

IT IS FURTHER ORDERED, that Respondent **Robyn L. Cammack**, pay partial costs of this matter in the amount of \$500.00, within 30 days of the date of this Order. Payment shall be made by **certified check or money order**, payable to the Wisconsin Department of Regulation and Licensing and sent to: **Department Monitor, Division of Enforcement, Department of Regulation and Licensing , PO Box 8935, Madison, WI 53708-8935**.

IT IS FURTHER ORDERED, that in the event Respondent **Robyn L. Cammack** fails to pay the \$500.00 partial costs within the time and manner as set forth above, then and in that event, and without further notice to the Respondent **Robyn L. Cammack**, her real estate salesperson's license shall be suspended without further hearing and without further Order of the Board, and said suspension shall continue until the full amount of said partial costs have been paid to the Department of Regulation and Licensing and her failure to pay the costs shall be considered a violation of this Order by the Board.

IT IS FURTHER ORDERED, that file 99 REB 240 be, and hereby is, closed.
